Implementation of cost recovery

Council Decision 482

The ITU Council determines the cost recovery principles and fees for satellite network filings Radio Regulations No.9.38.1 etc.

The WRC determines regulation covering satellite network filings, in particular, the penalty in the event of non-payment of cost recovery fee



Council Decision 482

Established a schedule of processing charge that relates to the complexity and size of a filing

Complexity is modeled with categories

Size is modeled by units

6 months to make payment

One free entitlement a year for each member state





 - For these categories, flat fee applies for units > 100






Fees for Coordination Requests

API date of receipt: after 19/10/2002

Conditions


For N1, N2, N3 only:

If application of **No.11.32A** has been requested, invoice will be issued for 100% of the fee.


Otherwise, only 70% of the fee will be invoiced and the remaining 30% will be invoiced if and when **No.11.32A** will be requested by the Administration.



Categorization of Notifications











Fees Scaling for Notification Filings





Invoicing

Upfront Stage:

Upon receipt of filing, the BR examines receivability

Invoice will be issued based on the category and units of the filing at that time (see SpaceCap)


Invoicing process

Publication Stage (IFIC):

Following the detailed examination of the notice, if the category or units of the filing is found to be different, any resulting excess fee (or refund) will be invoiced after the publication of the notice


Invoice will be issued to the Administration

Only if an Administration requests in writing, the invoice can be issued directly to the operator, with a copy to the Administration

Cancellation of a filing due to non-payment

WRC-2003 No.9.2B.1, 9.38.1 etc.

- The Bureau shall send a reminder 60 days before the due date for payment

If payment is not
received by the due date (which is
6 months from the date of the invoice), the
Bureau shall cancel the publication

WRC-2007

Extended to all notifications and some additional sections of Appendix 30B

 If notifications received and or after 1st
 December 2006

If payment is not received by 15 May
2008, the filings will be cancelled



Withdrawal or suppression of a filing by the Administration

Condition

Upon submission of a filing, an Administration can withdraw a filing within 15 days with no charge <u>After that</u>, the filing is chargeable even if it was withdrawn before its publication



Annual Free entitlement

Each member state shall be entitled to the publication of special sections for one satellite network each year without charge



Nomination of free entitlement

To be made by the member state in its role as the notifying administration

Should correspond to the year of receipt of the filing

To be made by the end of the period for payment of the invoice
